



Please read these Terms and Conditions carefully as they apply to your participation at the Australian Association for Research in Education 2024 Conference (AARE 2024 Conference).

By attending, speaking, exhibiting, or sponsoring at the AARE 2024 Conference, you agree to be bound by the Terms and Conditions set out below, which form a legally binding agreement between you and the AARE. As a condition of attendance, in-person delegates must agree to adhere to all Covid-safe measures put in place by AARE, the venue, federal or state guidelines and acknowledge that these procedures may be changed at any time in accordance with the latest health advice from the Australian Government.

AARE and Think Business Events (Conference Organiser) reserve the right to publish changes to these Terms and Conditions at any time without prior notice.

1. Definitions

1.1. General

1.1.1. The term 'AARE 2024 Conference', or the '**AARE 2024**' means the 'Australian Association for Research in Education 2024 Conference' of Australian Association for Research in Education (27 453 170 042) ('AARE').

1.1.2. The term '**Conference Organiser**' or the '**Conference Office**' refers to Think Business Events Pty Ltd (ABN 66 121 965 428) and representatives of Think Business Events ('TBE') is contracted by AARE to manage AARE 2024 Conference logistics, including registration, accommodation and sponsorship/exhibition bookings, and is the appointed data custodian for all personal data collected by AARE or Think Business Events for the purposes of promoting the AARE 2024 Conference related events.

1.1.3. The term '**Intellectual Property Rights**' includes all copyright and industrial and intellectual property rights of whatever nature, including without limitation all rights in relation to inventions, registered and unregistered trade marks (including service marks), registered designs, confidential information and circuit layouts, and all other rights resulting from intellectual activity in the industrial, scientific, literary or artistic fields including as defined in Article 2 of the Convention Establishing the World Intellectual Property Organisation of July 1967.

1.2. Registration

1.2.1. The terms '**Participant**', '**Attendee**', '**Delegate**' or '**Registrant**' refer to any person who registers and/or attends or is invited to attend the Conference – whether in-person or virtually – including but not limited to Speakers, Sponsors, Exhibitors, Vendors, Media Representatives and Contractors.

1.2.2. The term '**In-person Delegate**' refers to any delegate who physically attends the Conference in Melbourne.

1.2.3. The term '**Virtual Delegate**' refers to any delegate who only attends the conference online.

1.3. Speakers, program and Call for Proposals

1.3.1. The term **'Speaker'** or **'Presenter'** refers to any presenter or co-presenter, session chair, panellist or co-panellist, session moderator, session discussant, session facilitator or moderator who is participating at an AARE 2024 Conference session, whether in person or virtually.

1.4. Sponsorship and exhibition

1.4.1. The term **'Sponsor'** includes any person, firm, company or corporation and its employees and agents identified in the booking form or other written request for a sponsorship item.

1.4.2. The term **'Exhibitor'** includes any person, firm, company or corporation and its employees and agents identified on the application form or other written request for exhibition space.

2. Registration Terms and Conditions

2.1 All Attendees of AARE 2024 Conference (including all Delegates, Speakers, Exhibitors, Sponsors or Vendors) must be aware of, and agree to, the AARE 2024 Conference Registration Terms and Conditions.

3. PAYMENT OF REGISTRATION

3.1 The payment of the registration is either by credit card or bank deposit at the time of registration.

3.2 After 1 November 2024 midnight AEST, only payment made by credit card will be accepted.

3.3 A registration is considered complete when full payment is received by the Conference Organiser.

3.4 The Australian goods and services tax (GST) at 10% is applicable to all goods and services offered by the Conference. All registration fees listed include GST.

4. Early Bird registration fees

4.1 To qualify for early bird registration, registration fees must be paid in full by 27 September 2024.

4.2 If registration fees have not been received by 27 September 2024 your registration will revert to the standard Conference registration fee.

4.3 Registration fees are based on date of payment receipt, not the date of receipt of registration form.

5. MEMBER RATES

5.1 To qualify for member rates, you must be a member of AARE. Your membership status will be verified upon registration. Please contact AARE directly for further details at <https://www.aare.edu.au/membership/>

6. CONCESSIONAL MEMBER RATES

6.1 The Concessional Member Rate applies to AARE Concessional Members. Your membership status will be verified upon registration.

6.2 Delegates attending who are based in Low Income Countries (LIC) from the Indo-Pacific region, as defined by the [world bank](#), are eligible for concession and member rates as marked with astrix (*).

7. LATE REGISTRATION

7.1 The Conference Organiser cannot guarantee the availability of collateral, such as satchels or social function tickets such as the Welcome Reception to Delegates who register late (inside four weeks before the Conference starts) as there is a risk that social program functions may be fully subscribed. These tickets will be forfeited and the Conference registration fees will not be discounted.

8. TRANSFER OF REGISTRATION

8.1 All fully paid registrations are transferable to other persons from the same organisation.

Transfers can be made by the registered person in writing to the Conference Organiser at aare@thinkbusinessevents.com.au no later than 1 December 2024. Details must include the full name of the replacement person, their title, contact phone number and email address. All other registration details will be carried over to the new person unless otherwise specified.

8.2 Transfer of registrations to another person will include the registration, all associated social event tickets (including additional purchases).

Should the new Delegate not require an item previously booked by the original Delegate, the cancellation and refund policy for the item cancelled will apply.

8.3 Registrations are individual and cannot be shared.

9. NON-ATTENDANCE/NO-SHOWS

9.1 No refund will be made for non-attendance at the Conference or social events.

10. CANCELLATION OF THE REGISTRATION BY THE DELEGATE

10.1 All cancellations must be made in writing to the Conference Organiser at aare@thinkbusinessevents.com.au.

10.2 Full Conference:

10.2.1 If you have registered for the Conference as a full Delegate, whether virtual or in-person:

You are entitled to a refund if the cancellation is received on or before 1 November 2024. However, you will incur a \$150 administrative fee.

10.2.2 You are not entitled to a refund of the registration fees if the cancellation is received after 1 November 2024.

10.3. Part cancellation: If you would like to cancel part of your registration package (e.g. Additional social event tickets):

10.3.1 You are entitled to be refunded the fee that is applicable to the cancelled part of the package, if the cancellation is received on or before 1 November 2024. However, you will incur a \$25 administration fee.

10.3.2 You are not entitled to any refund of the registration fee if the cancellation is received after 1 November 2024.

10.4 Final date to claim a refund: To claim applicable refunds for cancellations or alterations, please email aare@thinkbusinesssevents.com.au on or before 1 November 2024. No refunds (in part or in full) will be accepted after this date, but you may choose to transfer your registration to another person within your organisation if permitted under these Terms and Conditions.

10.5 Processing time for refunds: Refunds (less applicable administrative fees) will be processed no later than 30 days after the conclusion of the Conference.

If your application for a visa to enter Australia is unsuccessful, the above cancellation terms apply.

11. CANCELLATION, POSTPONEMENT OR CHANGE OF REGISTRATION OF THE CONFERENCE AARE OR THE CONFERENCE ORGANISER

11.1 It may be necessary for reasons beyond the control of AARE or the Conference Organiser to alter the times, dates, itineraries or Speakers of the Conference by notice to you at any time.

11.2 In the event of cancellation or postponement of the Conference, or if the registration is converted from an in-person registration to a virtual-only registration (or vice versa), the maximum liability of AARE or the Conference Organiser is limited to a refund of the Conference registration fee with no additional liability for travel costs, hotel costs, or any other costs or expenses whatsoever.

11.3 In the event of cancellation or postponement of the Conference, or if the registration is converted from an in-person registration to a virtual-only registration (or vice versa), due to circumstances beyond AARE or the Conference Organiser reasonable control including but not limited to acts of terrorism, war, acts of God, natural disaster or global health crises (including any government restrictions on travel or gatherings), AARE or the Conference Organiser cannot be held responsible for any cost, damage or expense which may be incurred by Delegates as a consequence of such cancellation, postpone or change.

11.4 In the event of postponement of the Conference, if the Delegate is willing to attend the rescheduled event, we will transfer the registration and guarantee the same conditions and registration entitlements at the rescheduled event.

12. ACCOMMODATION OPTIONS

12.1 Some accommodation options are included for your consideration. You accept, acknowledge and agree as follows:

12.1.1 These options are not recommendations.

12.1.2 Any accommodation you choose is at your own risk.

12.1.4 Once a reservation for accommodation is made you must deal directly with the accommodation provider chosen by you.

12.1.5 None of AARE, the Conference Organiser or the Conference Office are parties to any contract you may form with any accommodation provider.

12.1.6 Any payment(s) made in relation to accommodation are independent of and separate from any conference registration fees.

12.1.7 Accommodation costs are not included in conference registration fees.

13. PRIVACY STATEMENT

13.1 AARE is required to comply with the requirements of the Privacy Act 1988 (Cth) (Australia). AARE reserves the right to modify or amend this privacy and copyright statement at any time, provided that those modifications or amendments comply with applicable laws.

14. USE OF PERSONAL INFORMATION

14.1 The Conference will collect and store information you provide in this Registration Form for the purposes of enabling us to:

- register your attendance at the Conference;
- assist with administrative and planning purposes;
- plan and develop the Conference and other events in the future;
- facilitate your requirements in relation to the Conference; and
- allow the compilation and analysis of statistics relevant to the Conference.

14.2 The information that you provide in the Registration Form and information provided at any other time during the Conference, including without limitation any feedback obtained during the Conference, will be used by the Conference to offer, provide, and continue to improve future events and other services.

15. VIRTUAL PLATFORM / CONFERENCE APP

15.1 All registered Delegates' name, position, organisation, and email address will be uploaded to the virtual platform and/or app.

15.2 Delegates will receive their Conference login details direct from the virtual platform and/or app. Delegates are responsible for the setup of their own Delegate profile on the virtual platform for interaction with other Delegates, sponsors and exhibitors

15.3 Delegates are also responsible for any technical requirements to enable you to use the link to the virtual platform provided by the Conference and to participate in the Conference via the virtual platform and/or app.

15.4 Registered Delegates will be able to set their privacy preferences when they log into the virtual platform and/or app.

16. DISCLOSURE OF PERSONAL INFORMATION TO THIRD PARTIES

16.1 The Conference may disclose some of the information that is collected in the Registration Form such as your name, position and organisation to Conference sponsors and exhibitors. The Conference will not otherwise, without your consent, use or disclose your personal information for any purpose unless it would reasonably be expected that such purpose is related to the offer, provision and improvement of the Conference or where such purpose is permitted or required by law.

16.2 Delegates may give consent for disclosure of their contact details to sponsors or exhibitors during the registration process or by notifying the Conference Office in writing by 1 November 2024.
